Reseller/Distributor Agreement Terms and Conditions:

1. Discounts:

- a. The Reseller will receive discounted quantity pricing of 50% off the list price for all products.
- b. No other discounts, coupons, or bundled packages will be applicable to the discount pricing.
- c. Reseller agrees to purchase at least 10 units at a time to receive the 50% discount. (This can be a mix of any models and any colors.)

2. Order Processing:

- a. To order products:
 - i. The Reseller will call in, email/fax an order form or a Purchase Order. (At present we do not process dealer orders via the online website, only via email/fax/phone).
 - ii. We will then send a pro-forma invoice with order total including shipping costs and shipping date.
 - iii. The Reseller will then make a payment on that invoice.
 - iv. We will then ship the products.
- b. All orders placed by Reseller will be non-cancellable and non-returnable.
- c. All prices are FOB NJ USA. Reseller is responsible for all shipping costs and any applicable customs fees.
- d. Payments are to be remitted in US Dollars before the products will be shipped.
- e. Products will be shipped once the payment has cleared our bank (this can take up to a week for a check).
- f. Payments can be made by Check, Money Order, or Wire Transfer. Credit Card and PayPal payments are also accepted with an additional 4% transaction/processing fee. CODs are not accepted.
- g. Product will only be shipped to the Reseller's registered address (**we do not drop ship products to the end-users**).
- h. We reserve the right to reject an order for any reason.

3. Terms:

- a. Reseller is free to set his own prices for his customers and can resell the products at any price.
- b. Reseller is not allowed to re-label or change the name of the products.
- c. Manufacturer may terminate this Agreement with Reseller at any time and for any reason.
- d. **Reseller shall abide by all the governing laws and regulations applicable to the type of products being sold and agrees to place an FDA disclaimer on all sales and marketing materials.**
- e. **Reseller agrees to extend to end-user the standard one year limited warranty against defects/workmanship.** Defective units are to be shipped at distributor's expense to Manufacturer for repair or exchange.
- f. **Reseller agrees to extend to the end-user the Manufacturer's standard 30 day 100% satisfaction guarantee. "100% Satisfaction Guarantee – with no questions asked refunds". Refunds are to be given to customers promptly.** Customer Returns are to be returned to Manufacturer for re-furbishing (shipping costs to be paid by Distributor).
- g. MANUFACTURER MAKES NO WARRANTY TO RESELLER, OR ITS CUSTOMERS, WITH RESPECT TO THE PRODUCTS, EITHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
- h. Reseller agrees to protect Manufacturer and hold Manufacturer harmless from any loss or claims arising out of anything having to do with the products or obligations.
